5. Presentation of Rider Development Grants

The Rider Development Grant is funded through sponsorship and directly by the Club Sponsorship funding of \$5000 was contributed by the Australian Communities Fund. Club funding was through an allocation of no more than 20% of accumulated funds from event profits, which this year will be \$4000. Total pool for the grant program is \$9000.

Due to declared conflicts of interest applications were reviewed by a nominated subcommittee; Bruce Halket, Lian Delany and Damian Grundy. All applicants were deemed successful.
