2. Previous Minutes

3. Business Arising

Update of Club's constitution as per Aus Cycling template.

Observation from Judy: Simplified, modernised and suitable for a sporting club. Jock — New constitution affords juniors voting rights at gm. This is fine. Chair loses rite to casting vote at general meeting. Term — extend to 2 years - 3/3 alternate years to avoid replacing full committee in any one year. Individuals can be voted back in (5 terms consecutively optionally include clause?). Audit requirements — club is low risk under the relevant act and not required for good governance.

Highline MTB Festival - MMBCC Partnership

Pump Track Proposal

Request for club permission to access plans developed for MMBCC previously (Kate). Motion moved previous meeting. Any further actions?

Station Precinct have plan for multi ability playground. Have a pump track on their plan (though different to MMBCC proposal). Meeting attended today. MMBCC now listed as stake holder. Focus of meeting that Kate attended today flagged that pump track should be a priority. Funding – potential for funding under Local Community Project Grants. Applications 15/3 to 15/April. Capped at 2.5M per LGA. Application from BD football club. Need to submit on a design/build contract basis (le World Trail). It will be key that we assign a project manager and that when complete the facility gets to Council's Asset Register for ongoing maintenance.
